EXHIBITOR TERMS AND CONDITIONS

- LIABILITY** – Kind Projects will not be responsible for any products and/or services sold or offered by The Exhibitor. The Show will not assume any responsibility for losses or injuries to property or persons, which might be incurred from pilfering, water damage, fire, accident, or any other cause.
- INSURANCE** – All Exhibitors must have commercial general liability insurance of TWO MILLION DOLLARS, and submit an insurance certificate or certified copy of the policy. This certificate must identify "Kind Projects" as an additional named insured, but only with respect to your business operations during the show. Show insurance can be purchased for a very reasonable price through Vendor Insurance - 1-888-708-6667; additional options available at www.jingleandmingle.ca.
- CANCELLATION POLICY** – If an exhibitor cancels, no monies shall be returned or credited.
- COLLECTORS FEES** – Any Exhibitor that does not meet all financial obligations when due will be responsible for all outstanding debts and any fees (including attorney fees and/or collection fees) Kind Projects incurs to recover the debt.
- LICENSE RELATIONSHIP** – It is understood and agreed that the Contract constitutes a non - assignable and privilege only and is not, under any circumstances, intended to constitute a lease or any other conveyance of real property, a partnership, employment agreement or joint venture between The Exhibitor, Family Jingle & Mingle and The Venue.
- NO SOLICITATION** – Exhibitors must not solicit outside of their designated space.
- LOCATION** – Family Jingle & Mingle Management as well as the venue reserves the right to locate, relocate or alter the licensed area assigned. Displays, demonstrations, distributions, distribution of advertising materials or sale items are not permitted outside The Exhibitor's Licensed Area.
- EXHIBIT CARE** – The exhibit must be attended throughout the show hours by at least one representative of the Exhibitor. It is the Exhibitor's responsibility to keep his/her area clean and orderly throughout the show and to ensure that it is ready for opening at the time the show opens. If the Exhibitor generates excessive amounts of trash, Family Jingle & Mingle Management may remove any trash or materials remaining at the close of the show at the Exhibitor's expense.
- EXHIBIT SETUP** – All exhibits must be set up within the time schedule specified in the Exhibitor Manual. If your booth is not removed within the time frame stated in the Exhibitor Manual the Exhibitor will be fined \$200 on your credit card or will be invoiced. No major changes to displays are permitted during public show hours. In the event of an Exhibitor's booth not being open at any time during show hours, Family Jingle & Mingle Management shall have the right to open the said booth with no liability to Kind Projects. The Exhibitor will be responsible for any loss or damages. Please limit the noise output within your designated area.
- PAYMENT** – Send e-transfer payments vendors@jingleandmingle.ca. Visa, MasterCard & PayPal are subject to a 4% service charge. In order to confirm booth space, completed application with full payment must be received. Payments are non-refundable and non-transferable. Should your application not be accepted, your payment will be returned. Space is available on a first come, first serve basis.
- INDEMNIFICATION** – The Exhibitor shall indemnify the show and its directors, officers, employees, volunteers, and Kind Projects from any losses claims, costs, and liabilities that may arise directly or indirectly as a result from granting this license. The exhibitor shall be solely responsible for all acts or omissions due to or caused by any person and any time while occupying the licensed area.
- ADVERTISING** – Family Jingle & Mingle logo/name may be included in the advertising of the Exhibitor; however, Kind Projects must be informed in advance of the content to be certain it is the interest of the show as well as the Exhibitor. The Exhibitor grants Kind Projects the right to use the name of the Exhibitor as a part of its advertising in so far as say that the Exhibitor is displaying his/her products/services at the show. Exhibitor agrees to advertise their attendance at the Family Jingle & Mingle on website and social media as available.
- AUTHORIZED SIGNATURE** – The required signature of the authorized signing authority shall be binding on the exhibitor and shall express acceptance of all conditions of the exhibitor.
- APPROVAL OF BOOTH** – Exhibitor space will be subject to show management approval. Management has the right to have you remove items for sale from your booth which it deems inappropriate or have not been preapproved on your contract. All food & beverage products must be pre-approved by Family Jingle & Mingle Management.
- SUB-LETTING** – The exhibitor named on this contract shall be the only company advertised in the assigned booth, unless pre-approval is received from Kind Projects. The Exhibitor shall not assign sub-let transfer or sell in whole or any part of the space allocated by Family Jingle & Mingle to any third party or have representative's equipment, printed materials, or products from any other business other than its own.
- SECURITY** – Security will be provided for move-in, during the show and take down.
- HYDRO/INTERNET** – Hydro is supplied by Showtech Power & Lighting. Internet is supplied by the venue. Both order forms are available at <http://www.jingleandmingle.ca/exhibitor-information/>
- TABLES/CHAIRS/LINENS/DRAPING** – Booth space does not include tables, chairs, linens - you may rent or bring your own.
- Goods must not be shipped to the show for shipping charges to be paid on arrival as these will not be accepted by Management.
